No. 2/5/2026-Leg/L: The following Act of the Legislature of Manipur which received assent of the Governor of Manipur on March 21, 2026 is hereby published in the Official Gazette:

THE MANIPUR APPROPRIATION (NO. 2) ACT, 2026
(MANIPUR ACT NO. 2 OF 2026)

AN

ACT

to authorize payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Manipur for the services of the financial year, 2026 - 27.

Be it enacted by the Legislature of Manipur in the Seventy Seventh Year of the Republic of India as follows:-

1. This Act may be called the Manipur Appropriation (No.2) Act, 2026.

Short Title

2. From and out of the Consolidated Fund of the State of Manipur there may be paid and applied sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate to the sum of Rupees thirty-one thousand three hundred fifty-six crore sixty-six lakh fifty-five thousand towards defraying the several charges which will come in course of payment during the financial year 2026 - 27 in respect of the services specified in column 2 of the Schedule.

3. The sum authorized to be paid and applied from and out of the Consolidated Fund of the State of Manipur by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.

4. References to Departments in the Schedule are to such Departments as existing immediately before the 1st day of March, 2026 and shall, on or after that date be construed as references to the appropriate Departments as reconstituted from time to time.


