No.ARS-202/1/2026-CAFANDPD-CAF&PD: The following draft of the Manipur Legal Metrology (Enforcement) (Second Amendment) Rules, 2026 further to amend the Manipur Legal Metrology (Enforcement) Rules, 2011, which the State Government proposes to make, in exercise of the powers conferred by section 53 of the Legal Metrology Act, 2009 (No. 1 of 2010) is hereby published, as required by sub-section (4) of the said section, for information of all persons likely to be affected thereby, and notice is hereby given that the said draft rules will be taken into consideration after the expiry of a period of fifteen days from the date on which the copies of the Gazette of Manipur in which this notification is published, are made available to the public;

Whereas, Priority Area (PA): 8 of the Compliance Reduction and Deregulation Phase-II recommends to allow licenses for manufacturers, repairers and dealers of weights and measures to be approved automatically based on self-declaration without requiring a government inspection and also allow verification and stamping of instruments used for commercial purposes to be based on self-certification for low risk weights and measures and on third party certification for all other categories;

The objections and suggestions, which may be received from any person with respect to the said draft rules before the expiry of the period so specified, will be considered by the State Government.

DRAFT RULES

**THE MANIPUR LEGAL METROLOGY (ENFORCEMENT) (SECOND
AMENDMENT) RULES, 2026**

1. Short title and commencement:- (1) These rules may be called the Manipur Legal Metrology (Enforcement) (Second Amendment) Rules, 2026.

(2) They shall come into force from the date of their publication if the Official Gazette.

2. Substitution of Rule 11.- For rule 11 of the Manipur Legal Metrology (Enforcement) Rules, 2011 (hereinafter referred to as the principal rules), the following rule shall be substituted, namely:-

“11. Registration of manufacturer, repairer and dealer of Weights and measures.- (1) Every manufacturer, repairer or dealer of weights and measures shall make an application to the controller or such other officer for issuing registration certificate as may be authorized in

this behalf, online, on such portal as may be specified by the State Government by issuing notification in the Official Gazette:

Provided that no registration certificate to the repair shall be required by manufacturer to repair weight or measure manufactured by him and used in a state other than the state of manufacture of the same, but the manufacturer has to inform in advance the concerned legal metrology officer about the repairing.

(2) Every registration certificate issued to a manufacturer, repairer or dealer shall be in the appropriate form set out in Schedule III.

(3) Fee for issuance of registration certificate to a manufacturer, repairer or dealer as specified in Schedule-IV shall also be paid online in the said portal or to the controller or such other officer for issuing registration certificate as may be authorized in this behalf.

(4) The fee payable for the alteration of a registration certificate or for the issue of a duplicate registration certificate shall be one half of the registration fee as specified in Schedule-IV.

(5) The form of online application shall be such as specified in Schedule II-A.

(6) The Controller or such other officer as may be authorized by him in this behalf, shall maintain a register of registration certificate issued to the manufacturers, dealers and repairers in the form as specified in Schedule V.

(7) Every manufacturer/repairer/dealer registered under the Act and these rules shall maintain such workshop/equipments /tools /registers etc. as the case may be, as per the terms and conditions of the registration.

(8) Every registration certificate issued under this Act shall be displayed in a conspicuous place in the premises where the registered owner carries on business.

(9) A registration certificate issued under the Act shall be based on self-declaration. The registration certificate shall be for perpetuity and no renewal shall be required. No prior inspection shall be required for grant of the registration certificate and the registration certificate shall neither be saleable nor transferable.

(10) On submitting required documents and fee, these registration certificates under the Act shall be granted within 14(fourteen) working days from the date of submission of application, otherwise the registration certificate shall be automatically granted.”.

3. Amendment of Rule 12. – In rule 12 of the principal rules

- (i) for the word “ licence”, wherever they occur, the word “ registration certificate” shall be substituted;
- (ii) in sub-rules (3), (4) and (5), for the word “licencee”, the word “ registrant ” shall be substituted.

4. Amendment of Rule 13. - In rule 13 of the principal rules, for the word “licenced”, the word “ registered” shall be substituted.

5. Substitution of Rule 14.- For rule 14 of the principal rules, the following rule shall be substituted, namely:-

“14. Verification of Weights or measures.- (1) Every person seeking verification and stamping of Weights and Measures used for commercial purposes shall apply in such manner as may be specified by the State Government by issuing Notification in the Official Gazette.

(2) A legal metrology officer may visit, premise within the local limits of his jurisdiction to inspect and test any weight or measure which is being or is intended or likely to be used in any transaction or for protection in pursuance of general or special order, instruction or authorization issued by the Controller of Legal Metrology shall be deemed to have been made under a lawfull warrant.

(3) The legal metrology officer shall obliterate the stamp on any weight or measure, if it is found during inspection that –

- (a) any weight or measure which being due for re-verification has not been submitted for such re-verification;
- (b) any weight or measure which does not conform to the standards established by or under the Act:

Provided that where the legal metrology officer is of opinion that the defect or error in such weight or measure is not such as to require immediate obliteration of the stamp, he shall inform the user, of the defect or error found in the weight or measure and call upon user to remove the defect or error within such time, not exceeding eight days and shall-

- (i) if user fails to remove the defect or error within that period, obliterate the stamp, or
- (ii) if the defect or error is so removed as to make the weight or measure conform to the standards established by or under the Act, verify and stamp such weight or measure.

Explanation.– The obliteration of the stamp on any weight or measure shall not take away or abridge the power of the legal metrology officer to seize such weight or measure in accordance with the provisions of the Act.” .

6. Amendment of Rule 19. – In rule 19 of the principal rules, in sub-rule (3), for the word “licenced”, the word “ registered” shall be substituted.

7. Substitution of Schedule-IIA.- In Schedule–IIA of the principal rules, the existing Form LM-1, Form LR-1 and Form LD-1 shall be substituted by the following Form LM-1, Form LR-1 and Form LD-1 respectively:-

In exercise of powers conferred under the provision of sub rule-1 of rule 11 of the Manipur Legal Metrology (Enforcement) Rules, 2011, the Government of Manipur, hereby, specifies the online portal for the purpose of applying for registration certificate for manufacturer, repairer and dealer of Weights & Measures, namely: -

- i. The single window portal **EODB Manipur** (URL **eodbmanipur.mn.gov.in**) shall act as the online portal for the purpose of registration for manufacturer, repairer and dealer of Weights & Measures under the Manipur Legal Metrology (Enforcement) Rules, 2011.
- ii. The procedure and documents required for online submission of application for registration certificate shall be specified in **ANNEXURE-‘A’**
- iii. A registration certificate issued under the Act shall be based on self-declaration. The registration certificate shall be for perpetuity and no renewal shall be required. No prior inspection shall be required for grant of the registration certificate and the registration certificate shall neither be saleable nor transferable.
- iv. On submitting required documents and fee, these registration certificate under the Act shall be granted within 14 (fourteen) working days from the date of submission of application, otherwise the registration certificate shall be automatically granted.

16. In pursuance of the provisions of rule-14 of the Manipur Legal Metrology (Enforcement) Rules, 2011, Government of Manipur, hereby specifies the manner of application for the purpose of verification and stamping of weights or measures used in any transaction or for protection, namely:-

- (1) Verification and stamping of low-risk weights and measures as specified in Schedule-I shall be made on the basis of submission of self-certification by the applicant in **Form-A** annexed in Schedule-I.
- (2) Verification and stamping of all other categories of weights and measures shall be made on the basis of third-party certification as specified in **Form-B** annexed in Schedule-I (third-party herein means any registered repairer who possesses bona fide registration certificate issued by the Controller).
- (3) Fees for verification and stamping of weights and measures as specified in rule 16 of the Manipur Legal Metrology (Enforcement) Rules, 2011, shall also be paid by the applicants.
