No. MED-1202/5/2026-HS-HEALTH: In exercise of the powers conferred by section 34 of the Manipur Nursing Council Act, 2005 (Manipur Act No. 13 of 2005), the State Government hereby makes the following rules further to amend the Manipur Nursing Council Rules, 2008, namely :

THE MANIPUR NURSING COUNCIL (AMENDMENT) RULES, 2026

1. Short title and commencement. — (1) These Rules may be called the Manipur Nursing Council (Amendment) Rules, 2026.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Insertion of rule 7A. — In the Manipur Nursing Council Rules, 2008 (hereinafter referred to as the principal rules), after rule 7, the following rule shall be inserted, namely:-

“7A.(1) Any person who is already registered or possessing a valid registration under any State/UT may not require separate registration in the State subject to fulfilment of conditions as below:

- i. Such a person shall be required to submit a self-certification in the format given at FORM 1 to the Manipur Nursing Council within 15 days from the date of start of practice. The Manipur Nursing Council shall maintain a separate list of such practitioners indicating his/her registration numbers in their respective nursing councils.
 - ii. The Manipur Nursing Council will independently undertake internal verification with the parent or presently registered state nursing council of credentials and veracity of such persons. If any such person is found, after due verification/enquiry, to have been involved in any misconduct, his/her enlistment in the separate list referred to at rule 7A(1)(i) shall be liable to cancellation.
 - iii. Such persons shall ensure full compliance of provision of the Manipur Nursing Council Act, 2005 and rules made by the State and all such provisions of Act and rules shall be applicable to him/her.”
2. Such person as mentioned at sub-rule(1) may also register if they so desire, at any point of time, by following the due procedure in accordance with the provisions of the Act and rules.”.
3. Insertion of FORM 1 — In the principal rules, the following FORM shall be inserted, namely:-
