2. Objectives of the Council

- To promote apprenticeship training in the State.
- To align industry requirements with vocational training.
- To improve employability of youth through structured on-the-job training.
- To support implementation of the National Apprenticeship Promotion Scheme (NAPS) and the National Apprenticeship Training Scheme (NATS).

3. Functions of the Council

- Advise the State Government on all matters relating to apprenticeship training.
- Reviews implementation of the Apprentices Act and Rules in the State.
- Promotes industry participation in apprenticeship engagement.
- Recommends measures for increasing apprenticeship seats and coverage.
- Supports integration of ITIs, Polytechnics, and industry under apprenticeship programmes.
- Monitors State performance under NAPS / NATS.
- Facilitates dispute resolution and policy interpretation where required.
